that grew on mobiles

Mega 'River March' to save natural streams of the city

More than 12,000 people gathered for a two-day campaign to spread awareness about the sad state of the four natural streams of the city- Poisar, Oshiwara, Dahisar and Mithi River.

Scientists here have identified three new species of microbes that flourished on mobile handsets. How grimy are the ubiquitous mobile phones?

Reports from Western nations have suggested that mobile phones are more often dirtier than toilet seats, with some smart phones even known to harbour deadly drug resistant bacte-

ria. The startling finding is by scientists of the government-owned National Centre for Cell Science (NCCS) here who have been able to identify three new species of microbes from screens of mobile phones.

Two bacteria and fungus, never before reported in scientific literature, were identified by this laboratory funded by the Department of Biotechnology.

Earlier a study done in 2015 by William DePaolo,



an assistant professor in the Molecular Microbiology and Immunology Department at the University of Southern California, found that toilet seats usually contained three different types of bacteria but mobile phones on an average housed some 10-12 different types of fungi and bacteria.

Mobile phones since they are carried in almost all human environments from the kitchen to the public transport harbour a larger diversity of micro-organisms.

These microbes grow well on the sweat and grime left on the phones as humans carry them around.

In Pune, Yogesh S Shouche and his team from the Microbial Culture Collection group of the NCCS collected samples from 27 mobile phone screens and they were able to isolate 515 different bacterial types and 28 different fungi.

These microbes are friendly to humans and usually thrive on our bodies, says Praveen Rahi, a co-investigator for the work.

'Suicide abetment case can't be quashed on settlement ground'

Pakistani national arrested for killing live-in partner

Mumbai: The Ulhasnagar police arrested a Pakistani national for killing his livein-partner since she did not divulge to the accused that she was an HIV patient.

Suraj Prem Seeju (22), a Pakistani national was arrested by the Ulhasnagar police on Saturday. He was produced at the Magistrate court and remanded to police custody of four days. Seeju worked as an autorickshaw driver at Ulhasnagar. Seeju had moved to Ulhasnagar from Pakistan in 2014.

According to Shakeel Shaikh, Senior Police Inspector, Ulhasnagar police station, "Seeja was not aware that Jagtap was an HIV patient. Once he found out that he had contracted the disease, he fought with her frequently. In August last year, Seeju had found out that Jagtap was already married and had two children. Due to which fights escalated often between them." On Monday morning, Seeju called Jagtap on her mobile phone number and asked her to meet him at Gol Maidan at Ulhasnagar. He slit her throat with a sharp knife and then fled away from the scene. "We had received a tip-off that Seeja would be visiting Shanti nagar at Ulhasnagar at Thane. We laid a trap and nabbed him." "During interrogation, Seeju confessed to his crime. We recovered the murder weapon from him," said Shaikh. Seeju has been arrested for murder under Section 302 of the Indian Penal Code.
